COURSES

AUTHORIZED PERSON 4 HOURS

This half-day program is designed for those individuals who are working directly where and when fall hazards are present and are required to use fall protection systems, equipment, or devices.

AUTHORIZED RESCUE 8 HOURS

This course will teach the student how to perform a "PROMPT" rescue in a fall arrest event. Not only is this a legal requirement, but a best practice for anyone that works at heights, regardless of industry.

CONFINED SPACE AWARENESS 8 HOURS

This course will instruct participants how to identify and classify different kinds of confined space, the permits required, the hazards associated with these spaces and the entry procedures required by Federal OSHA 1910.146 or the representative state OSHA.

CONFINED SPACE NON-ENTRY RESCUE | 16 HOURS

This module includes the Confined Space Awareness program plus instruction on tactical priorities of non-entry rescue, case histories, ventilation techniques and atmospheric monitoring strategies.

Minimum training required to be an Attendant, Authorized Entrant, and Entry Supervisor.

CONFINED SPACE RESCUE 24 HOURS

This course includes information regarding tactical priorities of confined space rescue, respiratory protective system options and requirements, as well as case histories of previous entry rescues.

Minimum training required to be an Attendant, Authorized Entrant, Entry Supervisors, and Rescuers.

DROPPED OBJECT PREVENTION AWARENESS 4 HOURS

This course is intended as a brief introduction to the hazards of dropped objects and will cover the basics of the dropped objects problem as well as the fundamentals of how to prevent dropped tools.

COMPETENT PERSON | 16 HOURS

This course has been designed for those individuals who fulfill the role of a Competent Person in either a Construction (OSHA 1926) or General Industry (OSHA 1910) environment.

COMPETENT PERSON REFRESHER 8 HOURS
